Subject: Empanelment of Engineers in Municipal Committee Leh under Ladakh Building Bye-Laws, 2024

NOTICE FOR EMPANELMENT OF ENGINEERS

In pursuance of the provisions contained under the **Ladakh Building Byelaws**, **2024**, applications are invited from **eligible engineers** for empanelment with the **Municipal Committee**, **Leh** for the purpose of scrutiny, certification, and supervision of building plans, development works, and allied activities within the municipal limits.

Eligibility Criteria:

- 1. **Resident** must be resident of Ladakh and must possess a valid Ladakh Resident Certificate issued by the competent authority as per extant guidelines.
- 2. **Registered office** must have a registered office in Leh (physical site inspection to be conducted by MC Leh)
- 3. **Qualification** Degree in Civil/Structural Engineering from a recognized University/Institution.
- 4. **Registration** Must be registered with a recognized professional body (Institution of Engineers or equivalent).
- 5. **Experience** Minimum 3 years of professional experience in building design, construction supervision, or urban development works.
- 6. **Good Standing** Should not have been blacklisted/debarred by any Government/Local Authority.
- 7. Must be conversant with the **Ladakh Building Bye-Laws, 2024** and relevant provisions of the National Building Code.

Scope of Empanelment:

- Preparation and submission, certification of building plans/drawings as per Ladakh Building Byelaws, 2024 within the Municipal Limits of Leh.
- Technical scrutiny and compliance reporting.
- Supervision of construction works for adherence to approved plans and structural safety norms.
- Certification under the **self-certification system** for applicable building categories as defined under Ladakh Building Byelaws, 2024.
- Compliance with professional responsibilities as defined under Ladakh Building Bye-Laws, 2024
- Any other task assigned under the relevant provisions of the Byelaws.

How to Apply:

Interested eligible engineers may submit their applications in the prescribed format (**Annexure-I**) along with the following documents:

- Copy of the valid Ladakh Resident Certificate
- Qualification (Degree) & Experience Certificates
- Copy of Registration Certificate (Institution of Engineers or equivalent).
- Recent passport-sized photograph
- Application form (Annexure I)

Submission Deadline:

Applications must reach the office of the **Executive Officer, Municipal Committee Leh**, either physically or via email at adm.mcleh@gmail.com by **20**th **September, 2025.** Incomplete or late submissions will not be entertained. The Municipal Committee reserves the right to reject any application without assigning reasons thereof.

Selection & Validity:

- The empanelment shall be done after due scrutiny by the Municipal Committee Leh.
- The panel shall remain valid for a period of **three (03) years**, subject to review/renewal as deemed fit by the Municipal Committee, Leh.

Important Notes:

- Empanelment does not confer any right of regular appointment or contractual employment.
- The Municipal Committee reserves the right to reject any application without assigning any reason thereof.
- Incomplete applications shall be summarily rejected.
